The Challenge.

The Maritime Coastguard Agency (MCA), a critical arm of the Department for Transport, is tasked with ensuring the safety of the maritime environment and those working on UK flag vessels. Their responsibilities include providing 24-hour maritime search and rescue services across the UK and internationally, alongside certifying ships and seafarers. Given the high stakes of their operations, the MCA faced the challenge of efficiently procuring essential safety, rescue, and operational equipment uniform.

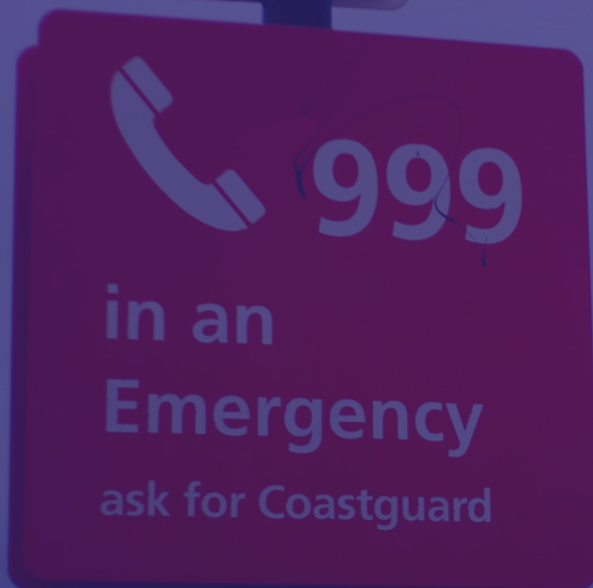
